**General Insurance Insurance Retirees Association south zone:-** south zone has its Annual General Meeting on 28<sup>th</sup> January 2017 & revitalized its functioning under guidance of Dy. General Secretary Shri U. Banerjee.

**GIPSA companies meeting Pensioners:-** the Ministry of pension & pensioners welfare has been endeavoring to treat the pensioners with dignity & honor. It has directed to invite pensioners greet them; listen to their views at least once in a year. It is extending support to identify pensioners Association, giving them grant for office, infrastructure like computers and even salary of the staff. GIPSA companies have such meeting as under.

**New India :-** every year New India is extending cordial welcome to new India pensioners in the first week of January at H. O. Mumbai. Such meeting was organized on 6<sup>th</sup> January in New India CMD. Shri G. Srinivasan along with General Managers Shri R. M. Singh, Shri R. Gangadharan, Dy. G. M. Shri I. Victor Amaladoss with other officials had interaction with pensioners. Our Chairman Shri R. P. Samal Presided & 83 pensioners of new India exchanged pleasantries.

**Oriental :-** Mumbai witness a large numbers of pensioners in meet of Oriental, on 2<sup>nd</sup> January 2017.

**United India:-** similarly United India Mumbai had meeting on 11<sup>th</sup> January 2017. MD India TPA was present to interact on staff Medclaim issues..

**Pune Thane:-** Oriental, United India & National companies invited Pensioners in Pune. Pensioners highly



appreciated their being greeted by their employers on 7<sup>th</sup> January in Thane pensioners meet.

**Nagpur:-** In Nagpur a large number of Pensioners are joining such get together by all PSU. Pensioners donate quite a sum to the pensioners Association led by vice President W.Z. Shri A. Kulkarni.

**Ahmedabad:-** Shri Pankaj Vithlani of General Insurance Pensioners Association Gujarat took lead & pensioners get together was organized in New India & Oriental this year.

**Developments from Jodhpur E C meet -** Federation has addressed a letter to Ministry of Finance to, instruct GIPSA companies to enhance the Family pension on the lines of RBI. This issue is urgent but Federation so far could not achieve the result.

**Wage Revision:-** In Banking & LIC explorative talks on next wage revision scheduled in February 2017. We Pensioners will have to peruse request to present pensioners say in wage revision of GIC also.

**Fund:-** Federation has sent out a fervent appeal to all affiliates & members to contribute @Rs.500/- per member to augment its fund as struggle requires fund which is meager with the Federation.

**Mediclaim:-** this issue is most dear to the heart of the pensioners. In order to consider improvement Federation was eager to know the Incurred claim ratio. The total picture is not yet clear. However New India has provided some data showing higher incurred claim ratio. We have immediately sought meeting with GIPSA Chairman in Mumbai. Since this could not materialized we have given a letter as under:

Sub:- our request for meeting for improvement in staff GMP w.e.f. April 2017.

Ref:- correspondence resting with our letter dt. 3<sup>rd</sup> November 2016. & dt. 3<sup>rd</sup> December 2016, (copy )

Sir,

We have been urging the GIPSA & GIPSA companies to improve upon the benefits allowed under staff GMP for the last three years. We have also requesting for providing the incurred claim ratio under the said scheme so that a joint efforts can be undertaken to cutting the claim ratio by bringing awareness, alerting the stake holders to ensure cost saving benefiting every one.

We apprehend that GIPSA is taking rigid stand while deciding renewal of staff GMP. The health Regulation direction issued by the IRDA will be taken as guiding for the renewal of staff GMP.

We appeal to you as Chief Executive of PSU that some dispensation ought to be given to GIPSA staff/retirees as mediclaim is the product of PSU. For this purpose even special dispensation ought to be sought from the IRDA if required. Such special consideration is extended to many corporate including LIC.

The GIPSA ought to take a favourable decision considering the genuine, reasonable, improvements requested by **General Insurance Pensioners All India Federation** in the past.

In brief we suggested:

A) Max Sum Insured Floater Basis --- Limit of Rs. 20 lakhs can be increased to Rs. 30 lakhs .

B) Charges for Diagnostic Tests without hospitalizations on the terms offered to LIC staff & retirees. These expenses are in the nature of Preventive Care and will result into saving in Hospitalization Expense.

C) Payment of Administration and Registration charges---

All most all the hospitals are charging these types of expenses as standard charges. Please consider



payment of these small expenses for which outgo will be negligible. ( administrative instructions stating " ( service charges: some hospitals, in metro cities like Mumbai etc. charge service charges..... such charges are payable.....if levying .....is standard policy..... )" )"

D) Some Other suggestions for improvement of scope of cover without much outgo are

1) ICU/CCU charges are capped as twice the normal charges which can be considered without limit

2) Ambulance charges

Limit is Rs1500/3000 up to 50 km/beyond 50 km during policy period per family. This limit is too small. Please revise the limit to Rs. 5000 per person per hospitalization without specifying locations.

3) Limit of 30/60 days for pre/post hospitalizations be waived in cases of renal failure /organ transplantations /heart diseases looking to specific requirement and nature of diseases.

4) Coverage for age related molecular degeneration / retinal failure be specifically provided.

5) In modern medical treatment, genetic disorder/stem cell implantations and surgery could be a part of treatment and should not be excluded . For treatment of Thalessemia, Hemophilia Sick cell, Anemia, Hemolytic Anemia, and Myeloma requiring hospitalization should also be covered as per sum insured .

**Eligible sum insured:** Growth in the health care cost affect the employees and retirees. It has eroded the value of sum insured more than 50%. We request to consider increasing the eligible sum insured to cope with the inflationary trend in the cost index of medical health care.

**GST:** whilst on this subject, we do not know exact impact of GST bill implementations but we request to exempt mediclaim insurance from GST as mediclaim being human centric and deserve exemptions. This will provide some relief to retirees, in-service employees' as well general insuring public at large. We request to move such proposal to the ministry if need be.

**Premium payment through annuity of pensioners:** We trust that payments of monthly pensions by LIC are made, as per data sent by GIPSA COS . Deductions for medical premiums can be effected from pension payments at H. Os level and LIC can be advised for net pension payments, while mediclaim premium monthly installments paid by pensioners can be accounted on the similar lines as being done in case of in-Service employees by suitable modifications in IT systems. This will avoid hardship of payment of premium in the month of Feb/ March every year and appropriate undertaking can be obtained from every retiree to that effect. In this process each co will be paying premium in advance and recovering in monthly installments at par with in-service employees.
