# RE: Issuance of Photo Identity Cards to Pensioners and Family Pensioners

We refer to the earlier instructions of our HO Personnel department for issuance of Identity Cards to all eligible Pensioners and Family Pensioners by the ROs.

Of late, it has been brought to our notice that though the ROs are issuing ID Cards to Pensioners, most of them are not issuing ID Cards to the Family Pensioners.

Hence this circular is being issued, instructing all our Regional Offices to issue Photo Identity Cards to all Pensioners and Family Pensioners without fail.

However, for easy identification of Pensioners and Family Pensioners by the ID Card issuing Authority, a Revised format of ID Card has been devised by us on the lines of the suggestions of GIPSA. The same is enclosed for your necessary action.

It may be noted that the photograph of the Spouse is to be made available on Pensioner's ID Card to enable the Regional In Charges identify them when they become eligible for family pension. Similarly the photograph of the deceased employee is to be made available on Family Pensioner's ID Card for easy identification of the eligible spouse of the deceased employee.

It is suggested that the ROs may issue New ID card to all pensioners in the Revised Format on or before 31.03.2018.
