### Re: Staff GMC Policy for the year 2018-19 – Final Option to include left alone Serving & Retired Employees and their dependent / independent family members

The Group Mediclaim Policy for Employees/Retired Employees was renewed with Oriental Insurance Company w.e.f. 1<sup>st</sup> April, 2018. and the last date for remittance of premium by retired employees was stipulated as 31<sup>st</sup> March, 2018 and subsequent extension was given till 13<sup>th</sup> April, 2018.

Representations have been received from various retirees and Unions/Associations and from Regional Offices to include the left out optees.

Based on the representation / suggestions received, one final option for joining the GMC for all employees whether serving or retired and their dependent / independent family members is approved for the benefit of all the employees to include them during the current policy ie. 2018-19.

Accordingly, it would be in order to provide coverage to the following:

1. Self, Dependent and/or independent family members of left over serving employees.
2. Self, Dependent and/or independent family members of left over retired employees.

The coverage is subject to the following conditions:

1. Premium has to be collected from day one ie.1<sup>st</sup> April, 2018
2. Claim if any during the break in period will be excluded
3. No increase/decrease in Opted Sum Insured is allowed

ROs may ensure that the revised instructions are circulated to all the operating offices so that all the retired and serving employees can make use of this facility of coverage under GMC Policy.
