JUDGMENT

Employees, who retired from service from various Insurance Companies, have filed this writ petition aggrieved by the denial of option to come over to the pension scheme which was introduced in public sector insurance companies in the year 1995. According the petitioners, several of the employees were not submit option account of the financial to on stringency as they had to refund the provident fund for coming over to pension scheme. amount pointed out that a further option was granted in public sector banks and similarly situated employees in the banks could avail the benefit of the scheme on the basis of the orders issued on 27.04.2010, by the Government of India. But in their case though the insurance companies had requested the Government for extending such a benefit to the retired hands from insurance the public sector companies, it rejected by the Government of India as per order issued on 05.06.2017. Aggrieved by the same, the first petitioner has submitted Ext.P13 representation before the first respondent requesting to reconsider the decision dated 05.06.2017 and to extend the facility for submitting option to come over to the pension scheme as given in Public Sector Banks.

2. I heard the counsel on both sides.

In view of the limited relief sought in this writ petition, I direct the first respondent to consider and pass orders on Ext.P13 representation, after

affording an opportunity of hearing to the first petitioner, within a period of 'three months' from the date of receipt of a copy of the judgment.

The writ petition is disposed of accordingly.
